The term <u>construction</u> includes any construction, reconstruction, demolition, alterations, repair work, renovation, or construction/renovation work related to the installation of equipment.

"Building Services" means any cleaning or routine building maintenance work, including, but not limited to, sweeping, vacuuming, floor cleaning, cleaning of rest rooms, collecting refuse or trash, window cleaning, securing, patrolling, or other work in connection with the care or securing of an existing building including services typically provided by a door-attendant or concierge. "Building services" shall not include skilled maintenance work, professional services, or other public work for which a contractor is required to pay the "prevailing wage" as defined in section 2 of P.L. 1963.c.150

CONTRACTOR REGISTRATION CERTIFICATION NOTICE

Effective April 1, 2020, any and <u>all</u> construction contracts awarded in New Jersey that require payment of prevailing wage must provide proof of valid Construction Contractor Registration Certification (CRC). Contracts that were awarded prior to April 1, 2020, do not have to provide proof of CRC. Bidders cannot list any subcontractors in any bid proposal unless the subcontractor is registered.
