### Affirmative Action, Prevailing Wage & Davis-Bacon Act:

Funds received under the Brownfields Impact Fund are subject to the Authority's affirmative action requirements, P.L. 1979, c. 203 (N.J.S.A. 34:1B-5.4), prevailing wage requirements, P.L. 2007, c. 245 (N.J.S.A. 34:1B-5.1) and the federal Davis-Bacon Act. For the Brownfields Impact Fund, the Authority's affirmative action and prevailing wage and the federal Davis-Bacon Act requirements shall apply to the remediation project and includes all contractors, all tiers. Prime contractors shall maintain and submit certified payrolls to the Authority to document compliance with Prevailing Wage requirements. For further information, please visit the following:

## Construction Contractor Registration Certification and new Apprenticeship Program Requirement

Effective April 1, 2020, any and <u>all</u> construction contracts awarded in New Jersey that require payment of prevailing wage must provide proof of valid Construction Contractor Registration Certification (CRC) and proof of participation if Registered Apprenticeship Program, if employing craftworkers. Bidders cannot list any subcontractors in any bid proposal unless the subcontractor is registered. Note that the NJ Prevailing Wage Act requires companies to comply with the new Apprenticeship Program.
