

Welcome: New Jersey Manufacturing Voucher Program- Final Application

Program Description

The New Jersey Manufacturing Voucher Program (NJ MVP) offers equipment grants of up to 50% of eligible equipment costs, including installation, with a maximum award amount of \$250,000. The program prioritizes manufacturers in Targeted Industries and manufacturers who integrate advanced or innovative technologies, processes, and materials to enhance their product manufacturing. Certified Woman-, Minority-, or Veteran-Owned Businesses (WMVB) located in Opportunity Zone Eligible Census Tracks, as well as companies with a collective bargaining agreement, may be eligible for additional bonuses. To support small businesses, NJ MVP awards reimbursement grants up to 50% of the project cost to manufacturers with fewer than 100 Full-Time Equivalent employees (FTE).

Applications will be accepted on a rolling basis and remain open until all funds are committed.

Eligibility:

Proposed initiatives must align with the priority occupations outlined in the pre-qualification application instructions and meet the criteria set forth in the program board memorandum. To be eligible, applicants must:

- Applicant company must be either a manufacturer in a Targeted Industry or the equipment to be purchased by the
 applicant company must meet the Advanced Manufacturing definition. (See Targeted Industry List and definitions:
 https://www.njeda.com/wp-content/uploads/2022/11/Appendix-C-Targeted-Industries-Definitions-12.6.22_v2.pdf
- Applicant company must provide a NJ Tax Clearance Certificate by the time of approval.
- Applicant company must be in substantial good standing with the New Jersey Department of Labor and Workforce Development (DOLWD) and New Jersey Department of Environmental Protection (DEP).

- · Applicant company must intend the equipment for use at a commercial or industrial location in New Jersey.
- Applicant company must have provided purchase quote, order proforma, and/or equipment listing during the prequalification application.
- Projects with executed contracts, a purchase order placed, or a deposit dated prior to submitting a pre-qualification for an NJ MVP application WILL NOT be considered for funding.
- Must have provided a plan during the pre-qualification application for using the requested equipment in their manufacturing process. Applicant company must intend the equipment for use in the manufacturing process. (Please see www.njeda.com/njmvp.)
- Not operate as a home-based business. Home-based businesses are not eligible.
- Have a total project cost (equipment and installation) of at least \$25,000
- Place the equipment order by June 30th, 2023, with an anticipated 12-month delivery and installation period, and two
 6-month extensions before funds are disbursed
- Applicant is not engaged in prohibited activities.
- Signer of the application must be an authorized signer (an owner, officer or otherwise have the legal authority to bind the business) of the business

Please note that projects where a contract, purchase order, or deposit has been made prior to submitting a full application will not be considered for funding. The Authority strongly urges applicants to wait until they receive final approval for the rebate from NJEDA prior to placing an order. Failure could result in a declination from the program.

All contracts worth \$2,000 or more, including manufacturer/supplier agreements requiring equipment installation, must adhere to the Authority's affirmative action and prevailing wage requirements as outlined in N.J.S.A. 34:1B-5.4 and N.J.S.A. 34:1B-5.1, respectively. All contractors and subcontractors must also be registered with the Public Works Contractor Registration Act, information for which can be found on the NJ Department of Labor's website.

Please note that if you do not provide the correct FEIN hat NJEDA has on file based on your pre-registration, the application will not allow you to proceed.




