Bond & Loan Financing:

The NJEDA issues conduit tax-exempt private activity bonds, the proceeds of which are used to provide financing. Direct loans through NJEDA are also available.

NJ Clean Energy Loans (NJ CELs):

A co-lending program for small businesses seeking to finance clean energy projects. Awards between \$250,000 and \$10M.

Premier Lender Program:

Partnering with banks to ensure that businesses and communities have the resources to expand and grow. Must be owner-occupied. Funding up to \$2,000,000.

Small Business Fund:

NJ businesses in operation for one year (not-for-profits in operation for 3 years) with revenue of less than \$3,000,000. Interest rates based on 5 Year Treasury rate. Funding up to \$500,000.

NJ Manufacturing Voucher Program (MVP):

A pilot program to provide manufacturers with grant funding to purchase manufacturing equipment. Max award of \$250,000.

Grants offered to small businesses for leases and improvements.

NJ Zero Emission Incentive Program (NJZIP):

A voucher program to support businesses with the purchase of zero-emission vehicles. Vouchers up to \$175,000.

Emerge Program:

For companies looking to make real estate decisions, provides per-job tax credits to projects that invest private capital into the state and create new or retain good-paying jobs.

Urban Enterprise Zone (UEZ) Manufacturers Energy Sales Tax Exemption:

UEZ-certified manufacturers that employ 250 full-time workers, at least 50% involved in manufacturing, may be eligible for a sales and use tax exemption.

Provides early-stage, product-based innovation companies matched funding with Angel investors. Funding will create an entrepreneurial ecosystem that will provide employment opportunities for NJ residents.
