Important Dates for Grantees to Consider



As a reminder, under the terms of your grant agreement with NJEDA, funds for this program must be expended by **December 31, 2026**. To meet this deadline, EDA wants to ensure you have key deadlines to track the successful completion of projects.

You must commence your project within 12 months of executing your grant agreement

Projects (both construction and FFE) must be completed within 12 months of your project commencement. In some cases, you may request an extension, however the dates above supersede those requests.

If you miss either of these deadlines, you will be in default of your grant agreement (Section 11) and EDA may take action as noted in Section 12.

All construction, regardless of start date must complete by 09/15/2026

This completion deadline applies to all all contractors working on your project, regardless of when they started construction.

All construction payment applications and disbursements must be submitted to EDA by 10/01/2026

All FFE disbursements must be submitted to EDA by 11/15/2026
